Political Campaign Deficit Tax

All Letters presented are letters to JPNA by individuals, who do not speak for it.

The economy is currently the hottest topic across the nation. It seems the only solution is to raise taxes with no plan on balancing the budget through cutting expenses. During the last election, we saw large amounts of cash spent by all politicians to gain office; for example, the Illinois Governors' race we saw a record over \$63 million spent in the primary and general election.

We first need to have financial records open to the public on the internet. An independent third party would audit the records to ensure they are accurate. If there is a deficit, then maybe levy special tax on politicians' campaign expenditures. The breakdown of the tax can be as follows:

- Incumbents being re-elected 2+ times would be taxed 50% on what they spend
- Incumbents seeking first time re-election would be taxed 30% on what they spend
- Candidates seeking election of non re-elected officials would be taxed 15% on what they spend
- Groups or individuals that spend money directly for campaign adds would be taxed 60% on what they spend
- Politicians not seeking re-election would forfeit existing funds and future funds for a period of 3 years

To protect the public from tax increases (e.g. Income Taxes) for the purpose of balancing the budget, an additional 10% should be added to the tax structure above. This would be in effect during the term of the political office.

The Political Campaign Deficit Tax would be levied if we were running at a deficit during any time since the last election. Perhaps if the reigning politicians feel the pain of the citizens, then they will take more care with how they spend our tax money.

Preserve your rights!

As an election judge for a number of years now, I'm always a little disappointed in turnouts. To give credit to my precinct (40th), they are apparently one of the better precincts for turnout at roughly 35%.

Really, 35% is good?!? Watch the statistics on election night, and you'll get a clear idea of the truth here.

So what that means is that 65% can't be bothered to get out and vote. OK, that sounds a bit harsh, and truth be told, because the election board is so careful of protecting voting rights that it takes 2 cycles to get someone off the polls if they die. That means there's always some percentage that won't be voting. (Seriously, despite the old jokes, no dead voting, not on my watch anyway)

And I know people get scared off by all those judges in certain elections. HEY—not this election. It's just city stuff this time. So that's no excuse. For what it's worth you can always skip any office you don't wish to vote for. The vote scanner may alert you that you've skipped certain major races, but it is your prerogative, and the ballot can be put through as you wish. Know also that if you can't decide between to candidates, you can't vote for more than one per race (unless specifically specified, as is often the case in water reclamation district races.)

If you have a hard time deciding, there're plenty of resources for help, newspapers, League of Women voters, etc. Find a group that reflects your interests, as a guide. You should also be aware that how you vote will not impact if your garbage gets picked up. (Yes, I really have heard that concern expressed!) For one thing, no one knows how you vote. This election is non-partisan, so you don't even have to declare a party. But even when you do, your party of choice cannot be held against you.

And time—the ultimate excuse. But with 2 weeks of early voting (starting 1/31), and the absentee voting option, really??? In all that there's got to be some way of voting. Also, think of it this way, by voting, you earn your right to complain about what politicians do in office!
